Please refer to our earlier circular no. IWLF-Cir./2018-19/60 dated 23rd October 2018.


It is once again submitted that sending of Whereabout Information on ADAMS website is mandatory for participation during **various Qualification Events for 2020 Tokyo Olympic Games in 2019 and 2020** on or before **1ST DECEMBER 2018**. Those States and Units who have probables with proven caliber to participate in International Competitions on merit may send the Whereabout Information of their respective athletes in the format below on or before the deadline of **1ST DECEMBER 2018**:-

Passport Number, attach copy validity must be upto 30.6.2020.	
Photograph, attach copy in .jpeg format

Training club / gym address with pin code and phone number	
Training days from 1.12.2018 to 31.5.2019 – Also mention time of training	
1 hour window where athlete has to be present at accommodation location w.e.f. 1.12.2018 to 31.5.2019.	

Those athletes who will not comply with sending of Whereabout Information on or before 1st December 2018 will automatically fail to participate in the EGAT Cup at Chiangmai (Thailand) from 8-11 February 2019 which will result in non qualification of athletes during 2020 Tokyo Olympic Games. Such lapse will be treated as the responsibility of the affiliated units and Departmental Boards.

Kindly treat this email as **MOST URGENT** and adhere compliance within the stipulated deadline of **1ST DECEMBER 2018**.
