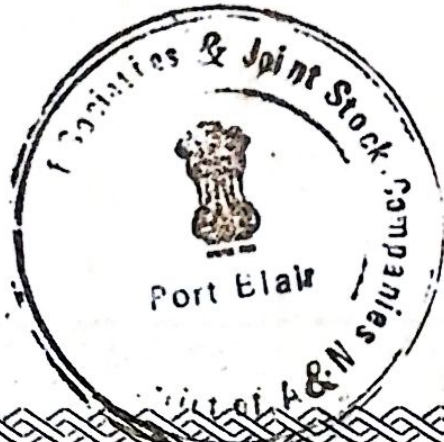

1. Welcome address

3. Decision to include the election process in the agenda points.


The above 1 – 3 items were proposed by Shri. M M Mehul and seconded by Shri. Varun Raj Padal B. The House unanimously approved the same.

3. Election of Executive Council

The Chairman of the meeting was informed to the House that the existing Constitution had seven (7) posts in Executive Council for a period of four years. Accordingly, the election process was started:



The House decided to organize the annual events and competition with the support of State Olympic Association till stable of the association and authorized to fix registration fee of event in view of the financial condition of the association and organizing committee.
