It is reiterated that no athlete is eligible to qualify during 2020 Tokyo Olympic Games who have not submitted their Whereabout Information to the Federation office on or before the deadline of 1<sup>st</sup> December 2018 along with scanned copy of passport and photograph. Any liability of untoward dope positive case by WADA / NADA will be the responsibility of department and State Associations. Also those athletes who fail to meet the deadline of submission of Whereabout Information will only be responsible for this lapse and loss of opportunity for qualifying for 2020 Tokyo Olympic Games.
