**Sub.: Procurement of imported ELEIKO weightlifting barbell sets on first cum first basis.**

Dear All,


Further to our circular no. 101 dated 23<sup>rd</sup> August 2019, this is final call for those State Associations who wish to procure imported ELEIKO weightlifting barbell sets from Indian Weightlifting Federation may send its requisition on the enclosed format. Distribution of weightlifting sets will be on first-cum-first basis and restricted to maximum of **4 (four)** barbell sets per State Association. **Those State Association who have not paid the ADMINISTRATIVE DOPE PENALTY due towards them are not eligible to procure the weightlifting sets, till the time fine is paid in full.**

The ELEIKO weightlifting barbell sets will be delivered to the designated address of State Associations given in the form at Serial no. 5, transportation charges will be **FREE OF COST**.

It will be the sole discretion of Indian Weightlifting Federation to distribute any number of sets to the State Associations if the sets will be left in the stock after normal distribution will be finished.

Those States who have sent its requirement are advised to submit appropriate address of delivery of sets along with name and telephone number of designated person on priority basis to Federation office by email on **20<sup>th</sup> December 2019.**
