Secretary, Karnataka State Weightlifter's Association and Chairman of Alva Education Foundation for hosting the 70th Men & 33rd Women Senior National Weightlifting Championships at Moodbidri, Mangaluru, Karnataka in grand manner.

Item No. 2: Amendment to the Constitution Article X:-

The Secretary General informed the House that in order to solely promote the sport of weightlifting in the State Associations, it is imperative to focus on weightlifting sport and demitting the office of other sports Associations / National Federations by all the office bearers of Indian Weightlifting Federation.



The entire House unanimously approved the amendment to Article X of Constitution of Indian Weightlifting Federation as under:-

Article - X

Management:

5. No Office-bearer of the Federation shall be eligible to be an Office bearer, simultaneously, of any other discipline (sporting) National Sports Federation / State Association, excepting the State and Indian Olympic Association.

The President after taking approval of the House gave three months period to vacate offices to those office bearers who are holding any posts in other sporting disciplines / associations in their State or at National level other than Indian Weightlifting Federation or State / District Weightlifting Associations.

Item No. 5: Amendment in Technical Bye-laws for distribution of medals in total only:-

The Secretary General informed the House that at most of the International Events now-a-days the medals will be given for total event only and proposed to amend the bye laws of Indian Weightlifting Federation accordingly.

The entire House unanimously approved and ratify the technical bye laws for medal distribution in total event only for Youth (Boys & Girls), Junior (Men & Women) and Senior (Men & Women) National Weightlifting Championships from 2018-19 onwards.

Item No. 6: Revision of minimum qualifying weights for Youth (Boys & Girls), Junior (Men & Women) and Senior (Men & Women) for participation during Youth, Junior & Senior National Weightlifting Championships from 2018-19 onwards:-

The President announced formation of a review Committee consisting of following members to gave its recommendations to the Chair to revise the minimum qualifying standard for Youth, Junior & Senior weight categories for National Championships from 2018-19 onwards:-

Item No. 7: Bidding of 71st Men's and 34th Women's Senior National Weightlifting Championships-2018-19:-

No State Association came forward to bid for conducting 71st Men's and 34th Women's Senior National Weightlifting Championships-2018-19.

Item No. 8: Bidding of 14th Youth (Sub-Junior Boys & Girls) and 55th Men & 31st Women Junior National Weightlifting Championships-2018-19:-

The Secretary General informed the House that conduct of Youth (Boys & Girls) and Junior (Men & Women) Weightlifting Championships will be completed well within the calendar year, i.e. by end of December every year.

The following States have shown interest and bid for conducting 14th Youth (Sub-Junior Boys & Girls) and 55th Men & 31st Women Junior National Weightlifting Championships-2018-19:-

- (i) Telangana Weightlifting Association at Hyderabad
- (ii) Arunachal Pradesh Weightlifting Association at Itanagar.
- (iii) Orissa Weightlifting Association at Bhubhaneswar.

After deliberations, the bid goes to Telangana Weightlifting Association for hosting of 14th Youth (Sub-Junior Boys & Girls) and 55th Men & 31st Women Junior National Weightlifting Championships-2018-19 at Hyderabad between October and November 2018.

The Secretary General informed Shri M. Ramkoteswara Rao, President, Telangana Weightlifting Association to deposit the Capitation Fee and a detailed report for conduct of 14th Youth (Sub-Junior Boys & Girls) and 55th Men & 31st Women Junior National Weightlifting Championships-2018-19 at Hyderabad to Federation office within a period of 1 month for finalization of venues and dates of the Championships.

Item No. 9: Any other with permission of the Chair:-

1. The President nominated Shri D. Chandahas Rai, Vice President, Indian Weightlifting Federation to visit Visakhapatnam and submit a report after inspection of venue and hotels and the arrangements made by Andhra Pradesh Weightlifting Association for conducting 13th Youth (Sub-Junior Boys & Girls) and 54th Men & 30th Women Junior National Weightlifting Championships-2017-18 at Visakhapatnam from 21-25 February 2018. The travelling expenses will be borne by Andhra Pradesh Weightlifting Association.
2. The Secretary General informed the House that National Anti-Doping Agency, New Delhi is not conducting regular dope tests at District / State / National level (in competition and out of competition) even after intimation to their office and in such events an athlete should be given advantage of writing his / her name in record books who have created / break the National records during in competition or out of competition.

After deliberations, the entire House unanimously approved that *"National records will be made effective by an athlete where no dope tests were conducted after prior intimation given to National Anti-Doping Agency, New Delhi"*.

3. The Secretary General informed the House in the recent past one media channel has inappropriately blown out a fake and bogus news where it was told that doping is being carried out by the athletes at Eluru during Inter-District Weightlifting Championships from 1-3 December 2017.

Shri B. Venkatramaiah told the House that he has submitted his report to the President, Indian Weightlifting Federation.

4. The President praised the efforts of Shri Vijay Sharma, National Coach in bringing Saikhom Mirabai Chanu on the Gold Medal podium during 2017 IWF Senior (Men & Women) World Weightlifting Championships held at Anaheim (USA) from 27 November – 5 December 2017.

The Secretary General informed the House that strict discipline and vigil is kept in the National camps by the National Coach.

The entire House unanimously condemn the statements of former medalists and awardees given in the past in electronic and print media regarding performances of Indian athletes and the National Coach.

As there is no other business to be transacted, the Meeting ended with vote of thanks by Shri D. Chandrahas Rai to the Chair.











