It is submitted for your kind information that filing of nomination paper for election (Form 2) and Notice for Withdrawal of Nomination of Candidature (Form 5) as per Model Election guidelines of Ministry of Youth Affairs & Sports is enclosed for your reference.

The filing of nomination form will be made in person in the Federation office at WZ-78, First Floor, Todapur Village, Near P.U.S.A. Institute, New Delhi 110012 between 11:00 a.m. to 4:00 p.m. on  $23^{rd}$  and  $24^{th}$  October 2017.

The nomination of a candidate for election as Office Bearer or a Member of Managing Committee shall be proposed by one of the representatives of Member State / Union Territories whose name is included in the Electoral College list in Form 1 and also subscribed for 1 (one) such representative as seconder.

Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.

No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder, and if he so does, his signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.

No person shall be permitted to withdraw his name as proposer / seconder, once the nomination paper subscribed by him has been delivered to Returning Officer.

<u>Article XI</u> "Election and Tenure of Office Bearers" of the Constitution of Indian Weightlifting Federation will be final and binding on all concerned.

The withdrawal of nomination will be sent to the Returning Officer by email on 26th October 2017 from 11:00 a.m. to 3:00 p.m. at <a href="withing1018@gmail.com">withing1018@gmail.com</a> and <a href="withing1018@gmail.com">watsam@hotmail.com</a>.

## Extracts taken from page no. 7 & 8 of Constitution of Indian Weightlifting Federation

#### **ARTICLE-XI**

#### **Election and Tenure of Office- Bearers:**

- 2. All office bearers may hold offices as long as they are elected by majority vote. The term will be for four (4) years on following terms and conditions:-
- (i) No member shall hold the post of President for more than 3 consecutive terms of 12 years, whichever is less, but shall be eligible for election as President after one cooling off period.
- (ii) No Member shall hold any or both the posts of the Secretary General or the Treasurer for more than two consecutive terms or 8 years, whichever is less. S/He will be eligible for re-election to any of these posts aller one cooling off period.
- (iii) A member who has held any or both of the posts of the Secretary General or the Treasurer shall be eligible to hold the post of President without a cooling off period but will be subject to the provision that "No Member shall hold one or more Executive Post for more than five consecutive terms or 20 years, whichever is less. However, such member can hold more than one post consecutively within the above period of 20 years".
- (iv) The President / Hony. Secretary / Secretary General / Treasurer will cease to hold the office on attaining the age of 70 years.
- (v) Cooling off period shall mean a period of 6 months less than the term.
- (vi) Candidates who are State / Central Government employees and seeking election who fall under the C.C.S. Conduct Rules, 1964 shall be allowed to hold elective office in any National / State / District Level for a term of 4 years, or for one term, whichever is less. In addition, they are also required to obtain NOC from their respective departments before seeking such election.
