MINUTES OF ANNUAL GENERAL COUNCIL MEETING OF INDIAN WEIGHTLIFTING FEDERATION

held on Monday, 30th of October, 2017 at 10:00 a.m. at Hotel Grand, Nelson Mandela Marg, New Delhi 110070

1. <u>Welcome</u>: Shri B.P. Baishya, President welcomed the members and dignitaries in the House and informed about his recent achievements where he was elected as the Executive Member of International Weightlifting Federation and also the Chairman of Ethics and Disciplinary Committee, International Weightlifting Federation.

He was also promoted to the post of Vice President in Asian Weightlifting Federation.

The President and other dignataries on the dias welcome the Returning Officer and Observers from Ministry of Youth Affairs & Sports and Indian Olympic Association and left the dias for proceedings of Item No. 5 of the Agenda.

<u>Item No. 5</u>: Election of Executive Committee / Council consisting of office bearers and Members as per Constitution of Indian Weightlifting Federation:-

Sh. Mukesh Vatsa, Judicial Officer (Retd.), Delhi District Courts, Returning Officer took the Chair along with Shri Ashwani Kumar, Project Officer (TEAMS), Sports Authority of India MYAS Observer and Shri Mukesh Kumar, Associate Joint Secretary, Indian Olympic Association (IOA) – Observer IOA and started the proceedings of the Election of Executive Committee / Council consisting of office bearers and Members as per Constitution of Indian Weightlifting Federation.

The Returning Officer told the House that 30 State Units with voting rights are affiliated with Indian Weightlifting Federation and maximum 60 members can exercise their power of right to vote in the Elections from those 30 State Units. On the present day, 29 out of 30 State Units are participating in the Elections of Indian Weightlifting Federation with total strength of 55 members out of 60 members were present in the House.

The Returning Officer further told the House that elections were being held in accordance with the Model Election guidelines of the National Sports Development Code formulated by Ministry of Youth Affairs & Sports and Constitution of Indian Weightlifting Federation and briefed as under:-

(i) Letter of notice was sent to the affiliated States of Indian Weightlifting Federation by speed post and by email on 6th October 2017.

(ii) Schedule of elections was published on the website of Indian Weightlifting Federation on 14th October 2017 and sent / notified to all affiliated States of Indian Weightlifting Federation by email.

(iii) List of electoral college was published on the website of Indian Weightlifting Federation on 17th October 2017 and sent / notified to all affiliated States of Indian Weightlifting Federation by email.

(iv) Nomination and Withdrawl forms was published on the website of Indian Weightlifting Federation on 17th October 2017 and sent / notified to all affiliated States of Indian Weightlifting Federation by email.

(v) Time for filing of Nominations was on 23rd & 24th October 2017 from 11:00 a.m. to 4:00 p.m. in the office of Indian Weightlifting Federation at WZ-78, First Floor, Todapur Village, New Delhi 110012 to Shri Mukesh Vatsa, Judicial Officer (Retd.), Delhi District Courts, Returning Officer.

(vi) Nomination was filed for the various posts by candidates - One President, Seven Vice Presidents, One Secretary General, One Hony. Secretary, One Treasurer, Seven Joint Secretaries, Five Executive Members to Shri Mukesh Vatsa, Judicial Officer (Retd.), Delhi District Courts, Returning Officer.

(vii) After scrutiny, the Returning Officer rejected two (2) Nomination papers for the post of Joint Secretary due to incompleteness of nomination papers.

(viii) From no. 3 and 4 of electoral proceedings was published on the website of Indian Weightlifting Federation on 24th October 2017 evening and sent / notified to all by email by the Returning Officer.

- (xi) Shri Raj Mahavir Singh and Shri Santosh Sinhasane, whose nominations as Joint Secretaries were rejected by the Returning Officer did not prefer to challenge the same before the Returning Officer till now.

The Returning Officer announced that as the filing of valid nominations are exact or less than the posts available as per the Constitution of Indian Weightlifting Federation, there is no need of printing of ballot paper for elections and all the candidates have been declared elected as uncontested.
