EXTRACTS FROM CONSTITUTION OF INDIAN WEIGHTLIFTING FEDERATION

ARTICLE-XI

Election and Tenure of Office- Bearers:

- 1. The election will be held by an electorate consisting of accredited two representatives from each affiliated State / UT unit who will propose and second the candidature of persons considered suitable for such office. The accreditation of unit nominees will duly be certified for both the President and Secretary at respective units. Such accreditations will be delivered to the Secretary General at least 7 days prior to the date of electoral meeting. The accredited representation should not be an office bearer of any other state / unit. Refer Article-X 1(a) for details.
- 2. Election shall be held once in four years.
- 3. All office bearers may hold offices as long as they are elected by majority vote. The term will be for four (4) years on following terms and conditions:-
- The President can hold the office for a maximum period of three (3) terms or twelve (12) years with or without a break between the terms.
- (ii) No Member shall hold any or both the posts of the Secretary General or the Treasurer for more than two consecutive terms or 8 years, whichever is less. S/He will be eligible for re-election to any of these posts after one cooling off period.
- (iii) The Office Bearers i.e President / Secretary General / Treasurer will cease to hold the office on attaining the age of 70 years.
- (iv) Cooling off period shall mean a period of 6 months less than the term.
- (v) Government servant may be allowed to hold elective office for period of two terms or for a period of 5 years, whichever is earlier, for which prior sanction would be required from the Government.

- (vi) Office Bearers and other members of the Federation shall be elected by secret ballot.
- (vii) No Proxy Voting shall be allowed in any circumstances.
- 4. Elections will be held as per Election guidelines of the Federation as per Annexure-I.

EXTRACTS FROM

Election Bye-laws of Indian Weightlifting Federation Election of Office Bearers and Other Members of Executive Committee

Eligibility for a Candidate;-6.

The eligibility of a candidate to contest for election of IWLF shall include the followings:-

Shall be citizen of India. (i)

Shall be voter in Electoral College list. (ii)

Shall not have been declared insolvent. (iii)

Shall not have been banned by IWLF. (iv)

Shall not have been convicted in any criminal case.

Shall obtain previous sanction from the Central/State Government if he or she is a (v) government servant and shall be allowed to hold office for a maximum duration of five (vi) years or two terms whichever is less.

Nomination of Candidates: 7.

- (1) The nomination of a candidate for elections office Bearer or Member of the Executive Committee shall be made in FORM 2.
- (2) The nomination of a candidate for election as Office Bearer or a Member of Executive Committee shall be proposed by one of the representatives of Member State / Union Territories name is included in the Electoral College list in FORM 1, and also subscribed by 1 (one) such representative as seconded.
- (3) Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.
- (4) Each nomination Paper Shall be delivered personally to the Returning Officer in person by the candidate himself / herself on or before 25.09.2021 upto 1 p.m.
- (5) No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- (6) No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to returning Officer.
- (7) The Returning Officer shall prepare a list of all nominations, Received by him post wise in FORM 3 and publish the same on website and IWLF Office by 2 pm. on 25.09.2021.



8. Scrutiny of Nominations:

- (1) On 25.09.2021, at 2.00 P.M., the Returning Officer in his office shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.
- (2) At the scrutiny of nominations, each candidate or one of his/her authorized representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination.
- (3) As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a list of validly nominated candidates in FORM 4 and the contesting candidates can take a copy from the Returning Officer on 25.09.2021 or from Website.

9. Withdrawal of Candidatures:

- (1) Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, on 28.09.2021 up to 3:00 P.M.
- (2) Notice of withdrawal of candidature shall be submitted in FORM 5, either by the candidate himself/herself or by a person duly authorized by him/her in writing.
- (3) Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- (4) The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- (5) As soon as may be or upto 3:00 P.M. on 29.09.2021, the Returning Officer shall prepare the final list of contesting candidates in FORM 6, display a copy of the said list in conspicuous place in his Office and on IWLF's Website and also furnish a copy of the same to each of the candidates/ their authorized representatives, if they so demand.
- (6) The names of the contesting candidates in FORM 6 shall be arranged, for each post, in alphabetical order according to English alphabets.
