The President informed the House members that in order to avail railway concession for athletes participating in Senior (Men & Women), Junior (Men & Women) and Youth (Boys & Girls) Weightlifting Championships, the change of signatures of Secretary General has to be notified to General Secretary, IRCA, Chelmsford Road, New Delhi with request to inform all the divisional and sub-divisional office of Indian Railways across the Country to facilitate rail travel concession for athletes participating in National Weightlifting Championships held every year.

The President told the House that Government of Odisha has shown keen interest in development of weightlifting game as a core sport in Odisha and also proposed to conduct the 74<sup>th</sup> Men & 37<sup>th</sup> Women Senior, 57<sup>th</sup> Men and 33<sup>rd</sup> Women Junior and 17<sup>th</sup> Youth (Sub-Junior Boys & Girls) National Weightlifting Championships-2021-22 at a mutually agreed date and venue.

**Item No. 9: Finalization of venue of 75<sup>th</sup> Men & 38<sup>th</sup> Women Senior, 58<sup>th</sup> Men and 34<sup>th</sup> Women Junior and 18<sup>th</sup> Youth (Sub-Junior Boys & Girls) National Weightlifting Championships-2022-23:-**

The President told the House that Tamil Nadu was earlier given the responsibility of conducting Senior National Weightlifting Championships for the year 2020-21 which was deferred due to COVID-19 pandemic, hence the first right of hosting of 75<sup>th</sup> Men and 38<sup>th</sup> Women Senior National Weightlifting Championships-2022-23 will be given to Tamil Nadu at a mutually agreed date and venue. The President further told the House that Kerala has shown interest to conduct 57<sup>th</sup> Men and 33<sup>rd</sup> Women Junior and 17<sup>th</sup> Youth (Sub-Junior Boys & Girls) National Weightlifting Championships-2022-23. Both Kerala and Tamil Nadu have shown their interest to hold all three Championships together.

After deliberations, the entire House unanimously approved the hosting of Youth, Junior and Senior Championships-2022-23 in Tamil Nadu at a mutually agreed date and venue.

The President informed the House states of Uttarakhand and Madhya Pradesh are not complying directions of Indian Weightlifting Federation and weightlifting activities come to a standstill in these States. Both of the State Associations have not registered themselves under the Registrar of Societies.

For the same all State Associations have to conduct doping seminar for athletes, coaches and support staff on regular basis by seeking the assistance from National Anti-Doping Agency, New Delhi for a faculty speaker.










As there is no other business to be transacted, the Meeting ended with vote of thanks by Shri S.H. Anande Gowda to the Chair.






