MINUTES OF EXECUTIVE COMMITTEE MEETING OF INDIAN WEIGHTLIFTING FEDERATION

held on Thursday, 29thof September, 2022 at 5:30 p.m. at Mahatma Mandir, Gandhinagar, Gujarat

Welcome: Shri S.H. Anande Gowda, Secretary General welcome all dignitaries and special Invitees in the House.

The Secretary General congratulated President, Indian Weightlifting Federation for winning the post of Vice President of Commonwealth Weightlifting Federation in the recently concluded elections held during 22nd Commonwealth Games Birmingham United Kingdom. He further congratulated the President, National Coach and athletes for winning 10 medals for India during 22nd Commonwealth Games, Birmingham United Kingdom.

The President informed the House that the ongoing dispute in the state of Kerala and Madhya Pradesh has been resolved and now the functioning in both the states will be the robust for welfare of athletes. He further informed that there are still some states and U.T.s who are not containing their internal disputes which have resulted in non-participation of athletes to the fullest. The lingering dispute of Telangana state and incomplete maintenance of documentary records had put the federation in bad light in front of Hon'ble Chair of Central Information Commission. There is another dispute in the U.T. of Puducherry which came to the notice of Federation only recently when order of the Hon'ble High Court of Puducherry was received in the Secretariat Office.

The President emphasized the office bearers of the State Associations to take responsibilities to resolve their internal disputes with natural justice for welfare of its athletes.

The Secretary General took up the Agenda as under;

<u>Item No. 1</u>: Filing of nominations for various posts during proposed elections of Asian Weightlifting Federation in the month of December 2022 / January 2023 at Doha (Qatar).

The Secretary General informed the house that Asian Weightlifting Federation as announced its elections to be held at Doha Qatar from 30th December 2022 to 1st January 2023.

The deadline for nomination for elections for various posts will be 30th October 2022 and it is imperative that entire house should resolve in unanimity for recommendation of name(s) from Indian Weightlifting Federation.

The President informed the house that during the elections of International Weightlifting Federations held earlier at Tirana, Albania the Federation recommended the name of Mr. Birendra Prasad Baishya, Former President of Indian Weightlifting Federation for the post of Vice President & Executive Member, International Weightlifting Federation. It is further informed that Shri Birendra Prasad Baishya withdrew from the elections on its own without consultation of Indian Weightlifting Federation causing an irreparable loss to the Federation by denying any posts in the august organization of International Weightlifting Federation to an Indian representative.

After deliberations, the entire house unanimously resolved that Shri Sahdev Yadav, President, Indian Weightlifting Federation will contest for posts of Asian Weightlifting Federation as representative of Indian Weightlifting Federation. No other member is allowed to contest for any post from India.
