**Sub.: Urgent request for Immediate Compliance with Whereabouts Information on ADAMS Portal.**

Sir / Madam,

With due respect, this is to kindly inform all concerned that athletes who are included in the **Registered Testing Pool (RTP)** of the **National Anti-Doping Agency (NADA)** and the **International Registered Testing Pool (IRTP)** of the **International Weightlifting Federation (IWF)** are **mandatorily required to submit and regularly update their Whereabouts Information on the ADAMS Portal at least 15 days prior to the commencement of each quarter**, as per the Rules and Regulations of the International Weightlifting Federation and the World Anti-Doping Code.

It is observed with concern that **presently some athletes are not compliant with the Whereabouts Information requirements**, which may lead to serious consequences, including **Whereabouts Failures, Filing Failures, Missed Tests, and disciplinary action**, strictly as per anti-doping regulations.

In this regard, all stakeholders—including **State Associations, Departments, Units, and Institutions** are humbly requested to **immediately inform and ensure compliance of the athletes working under or representing their respective organizations**. Athletes must be advised to **submit/update their whereabouts information without any further delay** to avoid inadvertent violations / non participation in various sporting events in future.
