**Sub.: Ineligibility of athletes based on scrutiny of final entries – IWLF National Youth, Junior & Senior Weightlifting Championships 2025–26 – Modinagar, Uttar Pradesh from 3–14 February 2026.**

Sir/Madam,

This is to inform all affiliated State / U.T. Associations that the final entries submitted for participation in the IWLF National Youth, Junior and Senior Weightlifting Championships 2025–26 being held at Modinagar, Uttar Pradesh from **3<sup>rd</sup> to 14<sup>th</sup> February 2026** are under detailed scrutiny by the Indian Weightlifting Federation.

In this regard, it is hereby **clearly notified** that any athlete **found ineligible at any stage of scrutiny shall not be permitted to participate in the Championships**, irrespective of submission or provisional acceptance of entries in the Start List published by the Federation.

The **Federation Office reserves the absolute and unfettered right** to delete, cancel, or reject any entry **at any time up to the commencement of the competition**, if at any stage any **discrepancy, irregularity, suppression of facts or non-compliance** is detected with respect to the athlete's eligibility. This shall include, but shall not be limited to:-

- Non-participation or elimination in the concerned State Championships.
- Submission of incorrect, incomplete, or invalid NOC.
- **Non-submission / invalid submission of mandatory Whereabouts information.**
- Non-fulfilment of eligibility criteria as prescribed by IWLF.
- Any inconsistency or mismatch in documents, records, or declarations submitted.
- Any other grounds which, in the opinion of the Federation, are sufficient to render the athlete ineligible.
